- Be ethical in all aspects of our dealings with our supply chain as per our statements and policies.
- Encourage a focus on and continuous improvement of sustainable alternatives throughout our supply chain.

Considerate Neighbour and Community Engagement

- Act as a considerate constructor within the communities we work in, build relationships and seek to integrate with the neighbourhood and locality.
- Achieve harmonious and effective relationships in all interactions with local communities.
- Where possible, support the local community and its businesses by sourcing local goods and services, including the recruitment of local personnel.

Climate, Natural Resources and Circular Economy

- Manage our carbon emissions in line with our ESG strategy using renewables and alternative technologies to decarbonise our works.
- Select energy suppliers from renewable sources where available and use alternative fuels and renewable energy.
- Work with our project consultants and waste management contractors to divert material away from landfill and to focus on resource material management planning and the circular economy.

Our People

- Provide sufficient information, advice, training and supervision in relation to environmental sustainability to ensure that all persons working for or on behalf of Walls Construction are aware of their responsibilities and are competent to undertake their activities in a constructive manner.
- Consult with all relevant parties to improve environmental sustainability and to manage carbon, waste and resource usage in the Irish construction sector.
- Continue to fulfil our Equality, Diversity, Inclusion and Belonging commitments, having achieved a silver award from the Irish Centre of Diversity.
